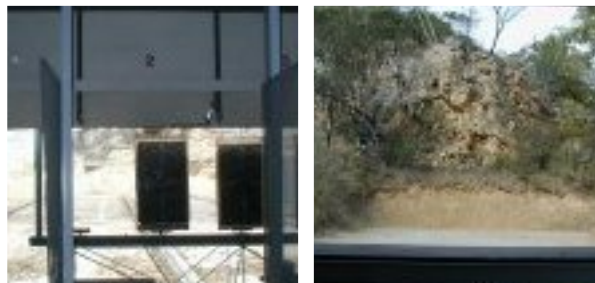

## Range Facilities

The range facilities include:

- 100m, 25m and 10m open ranges
- a 50m 20-lane turning-target ISSF range
- an undercover chrono range
- a two-storey 'mock house'
- several smaller ranges for short IPSC courses



The Club ranges are licenced for centrefire and rimfire rifles, shotgun (but not clay target) and handguns. Club-owned firearms are available for members to use. These include:

- semi-automatic pistols (.22 & 9mm)
- revolver (.357)
- rifles (.22, .357 & .303)
- shotguns (12g under/over & double barrel)
- black powder revolver

The Club provides ammunition for Club-owned firearms at a reasonable cost.

## Sporting Disciplines

Club Captains are responsible for coordinating competition events. An A-grade competition for each discipline is held once every month on the nominated Saturday afternoon:

- 1st: Service Pistol
- 2nd: Single Six, Shotgun, and Black Powder
- 3rd: IPSC
- 4th: Rifle and ISSF handgun

Members may also compete in the B-grade competition for each discipline on any Saturday.

The Club also hosts regular interclub, multi-discipline and speciality matches and events.

## Club Committee

The Executive and Club Committee are appointed annually. The Executive Committee is comprised of the President, Secretary and Treasurer. The Executive Committee may appoint additional Committee members to assist with the administration and operation of the Club.

Members are welcome to attend Club Committee meetings. Meetings are held on the second Wednesday of every month at The Tower Hotel, Magill Road, Magill. Meetings commence at 7.30pm. Prospective members are welcome to attend and make further enquiries about the Club.

AURRPC is affiliated with the major sports shooting associations and is also represented at the Combined Shooters & Firearms Council of South Australia.

The Secretary can answer your enquiries and assist with applications for firearms licences and club membership. A membership kit is available for download from the Club website at <http://aurrpc.org.au>. The Club is required by law to contact two personal referees to confirm that you are of good character. Firearms Branch, South Australia Police will conduct background check to ensure that you are a 'fit and proper person' to hold a shooting club member's licence and/or be a member of a firearms club.

## Membership

The membership types, annual fee and descriptions of the membership categories are:

Member .....	\$100.00
• Current serving ADF member	
Associate Member .....	\$120.00
• Civilians including ex-serving ADF members	
Associate Member (discount) .....	\$110.00
• Civilian (pensioner or student)	
Social Member .....	\$60.00
• Primarily a non-shooting member; able to participate in a maximum of four range events annually	
Family Member .....	\$30.00
• A direct relative (parent, spouse or child) of a Member or an Associate Member	

Membership fees are due annually on 1 January. Pro rata discount applies to membership subscriptions. A one-time joining fee of \$240 applies to new members.

## How to Apply

The process for joining a firearms club will depend on several factors such as gaining approval from Firearms Branch, whether you intend to obtain or already have a firearms licence, and the type of firearms licence sought or held. In most cases you should apply for a firearms licence or for a variation to your current licence. The application for club membership is separate and you will need to provide the following documents:

- Membership Application form
- two signed referees
- correct fee
- passport photo (print or emailed)
- Firearms licence and/or SAPOL letter

# General Information

## How to Obtain a Firearms Licence

You may make an application for a South Australian Firearms Licence at any police station by completing an *Application for a Firearms Licence* (Form PD303) for classes A1, B1 and H1. You will need to present 100 points of identification.

The Registrar of Firearms, once satisfied that you are a 'fit and proper person' to hold a shooting club member's licence, will issue you with a letter detailing the requirements for club training.

AURRPC has accredited instructors who will conduct the necessary training for members to obtain a Firearms Licence for classes A, B and H endorsed for club use (POU1).

After your training is complete, the Club will issue a instructor/club certificate (Form PD314) which you must forward to Firearms Branch as justification for your firearms licence application.

## Firearms and Ammunition

The *Firearms Act 1977* specifies the types of firearms that may be acquired. An *Application for a Permit to Acquire a Firearm* (Form PD306) must be sent to Firearms Branch for approval. There is a mandatory waiting period of 28 days. The Club must also issue a certificate supporting firearm purchases for club use.

New firearms licence holders are subject to a graduated access to handgun ownership. This is a legislated control that limits the number, type and calibre of handguns a new licence holder can possess and/or own in the first year.

AURRPC has Authorised Officers who are able to witness the transfer of possession of a firearm in accordance with the *Firearms Act 1977*. The firearm must then be registered at a police station within 14 days.

Ammunition may only be purchased by the holder of a firearms licence for a category of firearm that is endorsed on that licence.
